PHYSICAL THERAPY SERVICES AGREEMENT
Contract for Services
Independent Contractor

ARTICLE (1) AGREEMENT:

This agreement by and between the Lapwai School District, hereafter called "District" and Jamie L. Larsen (Building Blocks Pediatric Therapy, LLC) hereafter called "Contractor" is effective August 2020-2021. That for and in consideration of the mutual promises and covenants exchanged here, the parties agree as follows:

ARTICLE (2) PURPOSE OF AGREEMENT:

The Contractor shall provide Physical Therapy services for preschool students and students Pre-12th grade at Lapwai School District as authorized by the District. The services are intended to provide students with therapy, evaluation and intervention services. Hours of service may also include documentation time, meetings, and supervision of physical therapy aides/paraprofessionals, consultations with teachers and parents, as well as travel time.

ARTICLE (3) CONTRACT PERIOD:

This contract shall be effective for the period beginning August 2020. This agreement may be terminated with or without cause by either party upon THIRTY (30) days written notice delivered to the other party.

ARTICLE (4) CONSIDERATION:

Contractor shall provide Physical Therapy services as stipulated in Article 2 to identified school age students within the District for one day per week or up to 5 days per month during the 2020-21 school year. The fee for services will be \$85.00 per hour for therapy, evaluations, documentations, and meetings, consultation with teachers and parents and supervision of physical therapy aide/paraprofessionals and travel.

ARTICLE (5) TERMS OF CONTRACT:

- A. The Contractor will be fully licensed as a Physical Therapist by the Idaho State Board of Medicine and Bureau of Occupational Licenses.
- B. The District will abide by all provisions of the equal employment act.
- C. The Contractor shall maintain liability insurance to cover all operations and services to be performed by them pursuant to the terms of this Agreement. The minimum insurance limits of liability shall be one million dollars (\$1,000,000).
- D. This contract may be modified or amended in all or in part by joint agreement of the parties involved.
- E. The Contractor will provide a billing statement to the District by the 5th of each month for payment following the monthly School Board Meeting (typically the 3rd week of each month). The billing statement must include student name, date of service and total time spent with each student as well as date and time spent for documentation, travel, meetings and supervision of physical therapy aide/paraprofessional.

F. In the event of an extended school closure, soft closure or otherwise unplanned closing of the schools, the District will continue to pay therapist a minimum of 50% of typical invoice (an average of 3 previous invoices) for the days of work missed. The Contractor will work to provide services as able through remote styles available to students and families.
